PAH thanked all in attendance and was glad to see such a large crowd for something positive. Little did PAH know that in 1983, as part of the hiring Council of Albert Maalouf, that he could still be around to see him appointed as Chief of Police. Al Maalouf is the most experienced, educated, capable and dedicated candidate for this position. PAH is honored to have Chief Maalouf sworn in this evening.

Mr. Dineen was asked to swear in Albert Maalouf as Chief of the Harrington Park Police Department.

PAH read the following resolution into the record (from July 9, 2012 meeting).

#### RESOLUTION BOROUGH OF HARRINGTON PARK BERGEN COUNTY

WHEREAS, the Mayor and Council have established by ordinance a Police Department; and

**WHEREAS,** such ordinance has been from time amended to include new positions and to otherwise provide for the efficient operation of the Police Department; and

WHEREAS, there currently exists a vacancy in the police department at the level of Chief; and

WHEREAS, the Mayor and Council have determined that it is in the best interests of the Borough to have a Chief in the Harrington Park Police Department and Section 66-11 of the Borough of Harrington Park Code specifically authorizes same; and

WHEREAS, the Chief Financial Officer has certified that there are sufficient funds to pay for such official; and

WHEREAS, the Harrington Park Police Committee has recommended that Captain Albert Maalouf be hired as Chief of the Harrington Park Police Department to the Mayor, who endorses and now offers such individual to the Council for Approval; and

**WHEREAS,** the Mayor and Council are satisfied that it is in the best interest of the Borough to accept Albert Maalouf as Chief of the Harrington Park Police Department;

**NOW THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of Harrington Park, County of Bergen, State of New Jersey, as follows:

- 1. Albert Maalouf shall be appointed as Chief of the Harrington Park Police Department, effective July 16, 2012; and
- 2. The salary for Chief of Police shall be as stated in the salary ordinance.

PAH noted that this resolution was passed unanimously by all those present at the July 9, 2012 meeting.

PAH noted that the Police Committee made an excellent and thorough decision for the Chief position. Plenty of time and research went into this decision, covering all options.

Councilman Evanella welcomed all in attendance and explained the efforts of the Police Committee. All options were addressed and this decision is not just best for the department, but for the residents of Harrington Park. GE noted the list of Police Chiefs from other municipalities that were in attendance, along with additional representation from police departments throughout the area. Also in attendance were several retired Chiefs and police officers. GE assured all present that the right decision was made.
