EC also plans on working with the school for a rain garden and the Borough for a tree bank.

Concern has been made over the condition of the train tracks. ALB has already contacted CSX and reported the various holes and poor condition of the rail ties.

Request has been made to the DPW to place an additional garbage receptacle by the Convenience Store since it overflows on a regular basis.

Policy for Borough Maintenance-Green Team-Councilmembers should review This is a nice goal for the Borough to achieve. Recreation will be contacted so they may have some input. GE noted that even though organic grounds treatments may cost more initially, in the long run they are extremely beneficial. MR will discuss with Recreation at the next meeting.

Board of Health President is Dr. Lipton and Vice-President-Scott Weiner The Board is working on a BBP procedure as a requirement for PEOSHA. DPW, Ambulance, Fire and Police members need to have the required shots (if they so chose), required classes and all should be documented in one location. Currently \$2600 is in the budget to cover education and other related expenses. \$500 is always in the budget for BBP inoculations if necessary to administer to new employees. Mush of the work will be done in house at minimal expense.

John Schettino has been elected as the High School Board of Education President. The Harrington Park School has made and is reviewing current security procedures and making changes accordingly.

(**JP**) Police Department has been making a presence in the school in response to recent events in Newtown Ct. They will continue as much as possible in the future.

(MR) Consideration should be given to installing parking signs at Highland Field. Many people park haphazardly in the parking lot making maneuvering difficult and dangerous. No parking should be allowed by the rock by the basketball courts. MR would like to reach out to Neglia Engineering to see if the signage could be installed as part of the sidewalk grant since the installation of the sidewalks has created this situation. Perhaps there is still money left in the grant that could be spent.

PAH suggested that Chief Maalouf and Neglia Engineering be contacted to see what is

required for angled parking. ALB will contact both.

The corner of Parkside Road and Harriot Avenue also has some pothole and rough surface issues that need to be repaired. MR would like to authorize Neglia Engineering

to contact the County to add this location on to their paving list. JP agrees it is important for the County to be made aware of potentially dangerous situations.

(AN) Neglia Engineering Contract-Option two on the agreement correspondence is historically the one that the Borough has chosen for engineering services. Neglia has served the Borough well over the years. Resolution will be prepared for next week's agenda.

(JC) Advanced Waste is under contract to be sold and municipal consent is required from the Borough. Mr. Dineen is reviewing the document for a resolution at the next meeting.

Addendum RESOLUTION FIRE DEPARTMENT INTERBOROUGH MUTUAL AID

WHEREAS, it is the intent of the undersigned municipalities, its fire departments and respective fire companies to enter into a mutual aid and assistance program pursuant to and required by law as set forth in NJAC 5:75A-2.2, and

WHEREAS, this agreement is intended to supersede any earlier agreements which may have been signed between the parties hereto, and

WHEREAS, this agreement shall be by and between the following boroughs, towns, municipalities, fire departments and fire companies and the parties agree to be bound thereby,

WHEREAS, it is necessary to have an agreement to define the obligations and duties of the parties of the Interboro Mutual Aid Group;

NOW THEREFORE, in consideration of the mutual promises and covenants contained herein, the parties covenant and agree as follows:

(1) Call for assistance: All calls for assistance among the Mutual Aid members shall be made through the dispatch facility of the department or municipality requiring assistance to the dispatch facility for the town from which assistance is requested. The request for assistance shall come from the Fire Chief or other ranking officer in charge of the fire or emergency incident. The town(s) requesting the assistance shall give the following

- information: location of the fire or emergency incident, route to be taken, and type of equipment requested. Towns requesting assistance shall have a police radio car on the town boundary line to meet the apparatus and escort them to the location of the fire or emergency incident if needed.
- (2) The Fire Chief, Deputy Fire Chief, Assistant Fire Chief or ranking officer in charge of the fire department that called for assistance shall be in charge of the fire or emergency incident in accordance with NJAC 5:75 et. seq.. Apparatus reporting in from other towns shall report to the Staging Officer or other appropriate Commander at the scene prior to placing apparatus and personnel to work.
- (3) There shall be no charge imposed against any member municipality or department receiving personnel, apparatus or equipment.
- (4) Cost recovery may only be imposed where permitted by the New Jersey Uniform Fire Code; federal, state and local laws allowing for cost recovery involving hazardous material incidents; or cost recovery that is considered recoverable under law from responsible parties.
- (5) Each of the undersigned municipalities agrees to assume the cost of loss or damage to its own equipment.
- (6) It is understood and agreed that in the event of the failure of any of the departments to respond to the call for assistance, the department and municipality failing to respond shall in no way be liable.
- (7) It is understood that the Agreement will take effect and be operative by all municipalities and departments that sign same until such time as any municipality or department provides notice of their intent to withdraw from the mutual aid group. A 30-day written notice shall be given by any party to this Agreement of their intention to withdraw from this Agreement. The agreement shall remain in full force thereafter as regards the remaining signators.
