#### Ms. Gerri Gibney, 154 LaRoche Avenue

As President of the Historical Society as well as Chair of the Arts Council of Harrington Park, she has requested on behalf of the program that the Mayor consider an alternate name for his proposed program for cultural and art programs. She expressed concern of confusion between the two programs-facebook page, grants and other organizational items are already in place.

PAH responded that he had no problem with the request.

#### Mr. Vincent Landers-Vice President of Board of Trustees-Brookside Village (BSV)-20 Blanch Avenue #205

Mr. Landers read into the record a letter from Mr. Blakeman, Board Chair that addressed the high taxes placed on the residents of BSV. Members of the Board had met with the Mayor regarding the costs of living and possible solutions.

Next, Mr. Lander provided background information on Mr. Ken Fisher the next presenter.

He also read into the record a letter from one of the original planners of this project, Reverend Chuck Johnson. His letter addressed the original intentions of the BSV project and how they have been achieved over the past 25-30 years.

#### Mr. Ken Fischer, BSV Board of Trustees, 20 Blanch Avenue.

Mr. Fisher summarized the background of how Brookside Village was founded through the help of the Community Church. The intention of the program was to provide attractive, affordable, alternative housing for Harrington Park senior residents. Most has been achieved, except the affordability has increased almost 40%. Mandates that were required by the State and the Borough at the time of conception and construction were reviewed. Mandates included the purchase of a particular plot of land, for the Borough's set price with the inclusion of 12 low income units.

### Mr. Ed Farrelly-60 Blanch Avenue

Council should consider the inflation factor on those with a fixed means of income. Most seniors have to deal with the additional costs of medical needs and home care. In his opinion, the residents of BSV were hit harder by tax increases than other residents in the town.

### Irene DeGennaro, 60 Blanch Avenue

The taxes at BSV are affecting future sales. BSV is self-operated and has maintained a tight budget. Many prospective buyers have a hard time paying the taxes. In addition, some recent purchasers have sold due to the increase in tax rates.

#### **Bob Fisher, Brookside Village**

Explained that the trustees would like a 34% reduction in taxes across the board, moving forward. He explained the consideration of what has been mandated and previously spent, the price fixing of retail value of the units.

PAH inquired about the fact that units are selling for more than what they are assessed for. A profit is being made. Mr. Fisher stated that the increase in cost is not really profit, it is a cost of living increase or covers what has been spent to maintain the unit. PAH asked why BSV is not recommending their residents to follow the tax appeal process. Mr. Fisher answered that the reality is that the units that have been sold have limited the amount of comparable properties since many have been sold for either their assessment of more. Only a few have been sold for less.

Mr. Fisher thanked Council for their attention to the presentation and hopes that consideration would be made to this group of residents. All should reflect back on the original intention of the project, consider the price that was paid, and have the entire community of Harrington Park absorb the reduction request since many towns around the area lease the land to such senior type developments at a very minimal fee.

PAH addressed the audience and explained that legal counsel will have to advise accordingly. He thanked the presenters in recognizing that this deal was not made with the current Council, but from a different Mayor and Council prior to PAH election. PAH also recommended that anyone who can, should appeal their taxes in the appropriate manner keeping the April due date in mind.

JP interjected that he was under the impression that Council members do not have the power or jurisdiction to approve such a deduction.

#### Mr. Genco-Brookside Village

Stated that Council has a responsibility to BSV and should reconsider the contract from the creation of the project. PAH clarified that whether a contract is 30 years old or 3 years old, the same rules apply.

Discussion followed regarding the reduction given to BSV to help keep the project out of bankruptcy of about \$900,000.00, and how the land was acquired and the problems with the contractors and investors.

PAH thanked all for coming and discussing their request with Council.

## RESOLUTION TRANSFER JURISDICTION OF THE ELEVATOR SAFETY ENFORCEMENT SUBCODE BACK TO THE BOROUGH OF HARRINGTON PARK

**WHEREAS**, the Mayor and Council of the Borough of Harrington Park have determined to transfer jurisdiction of the elevator safety enforcement subcode back to the Borough of Harrington Park; and

**WHEREAS,** at the current time, the New Jersey Department of Community Affairs has that jurisdiction, but pursuant to NJAC 5:23-43(a)3, the Borough has the right to re-acquire jurisdiction of the elevator subcode duties by enacting a resolution; and **WHEREAS,** the Mayor and Council of the Borough of Harrington Park believe that it will be more cost effective and efficient for the Borough to provide those elevator inspection services;

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of Harrington Park that pursuant to NJAC 5:23-43(a)3, the jurisdiction of the elevator safety subcode shall be transferred from the Department of Community Affairs to the Borough of Harrington Park; and

**BE IT FURTHE RESOLVED**, that a copy of this resolution shall be forwarded to the Department of Community Affairs since the transfer of jurisdiction does not occur until 120 calendar days after a certified copy of the resolution is received by the Department of Community Affairs.

**FINALLY, BE IT RESOLVED**, that the Borough of Harrington Park has entered into a contract with New Jersey Technical Services (NJTS) Inc., 100 Schraalenburgh Road, Harrington Park, New Jersey to assume responsibility of the elevator subcode on the Borough's behalf as an authorized third party elevator inspection agency. In conformance with NJSA 40A:11-.1(a), solicitation of quotations is not required due to the estimated annual cost of the contract. The Borough and NJTS are willing to assume responsibility of the elevator safety inspections prior to the 120 day transfer period if it is convenient to the Department of Community Affairs.
