# Harrington Park 6<sup>th</sup> Grade Girl's Travel Basketball Team Certificate of Achievements were distributed to the 9 member team.

PAH addressed the audience to compliment the Harrington Park championship team. He has had the pleasure of honoring many Harrington Park teams, and the Borough is truly a home of champions. The team ended with a season of 16-0, many professional do not have that strong a season. He looks forward to see what other great accomplishment this group of athletes can achieve in the future. Also thanked were the parents, and coaches, that are an integral part of the local sports programs.

Coach Pasi added that the teams of 9 players were very cohesive and humble. He could not be prouder as a coach on the demeanor of the team. These types of results do not come very often. Coach Pabst stated that the team was so success due to their ability to play defensively. They were kind and generous to the teams they played.

Mr. Gregory Polyniak, Borough Engineer-Highland Lighting Project OBG project is almost complete-close out papers should be submitted shortly.

Lynn Street striping is completed and the municipality should be receiving the 25% payment left soon.

Generator project should be out to bid as soon as Neglia received all the information from their electrical subcontractor consultant.

Section 2 of Lynn Street – NJDOT grant \$149,000. Neglia has submitted a proposal for their services.

Neglia Engineering has been utilized by the school to oversee their playground project. This would be located on the side of the building/west ball field and will have additional accessible equipment.

COAH available land list was sent to Borough Planner to confirm what he will be including in the proposal being sent for consideration by the Courts.

Highland Lighting is ready to go out for bid. Different lights were selected, so less would be necessary since they are LEDs. It will cost the Borough about \$14,000 less than the original estimate. This fixture will also allow for banners and flags to be placed along the path. In addition to bidding the project, Neglia has included a five year maintenance contract option.

MRUT was concerned that the reduction of lights would be a problem. GP explained that the lumens from these fixtures would be more than adequate to cover what is requested. JC added that all the contributing organization are still donating the same funds, so the Borough will save the money for other open space projects. She added that electrical sockets have been added as well that could be useful for town day and for maintenance. Bid packages will be available on May 26, 2015 with the award in June or July.
