(AN) Planning Bd., Bd. of Adjustment, Construction, Fire, Ambulance Building Department took in \$8867 in fees for the month of January. This is up \$744 over 2015.
Fire Department had 24 calls, 1 Hazmat Drill with New Milford Fire Department and the County. 1 mutual aid call to Alpine, Old Tappan and 2 to Norwood.
2 Dills were held, 1 Officer's Meeting and 2 Truck Inspections. The turntable on Truck 569 Ladder is back in service. A FEMA grant has been submitted The Fire Chief attended training in Mahwah regarding accountability of first responders.

Board of Health: Next meeting is in March.

Environmental Commission: The EC will be applying for \$1500 Open Space Watershed Grant.

Spring Clean up at George Street Park-March 12th. Rain date March 19th. Paper Shredding Day is April 23, 3016. Discussion followed inquiring why it was not scheduled at the same time as History Day or the Garden Club Plant Sale. ALB explained that this date is chosen in November of 2015 and even as of this date she has not been notified when History Day or the Plant Sale is scheduled. ALB attempted to change the day and also suggested to the EC that Town Day may be a good alternative. After contacting the BCUA moving the date to another day in April was not an option. The EC informed Alb that the date will stay as scheduled.

(JP) Finance, Exec. & Admin., Grants

Meeting was held on February 13, 2016-Budget items were reviewed. Surplus will be increased. Auditors have started their process to end 2015.

The budget is under the 2% CAP, and overall taxes may increase 2.5%. Major reason is that the Borough bonded for capital items and now it's time to pay for them. This increase amounts to about \$75 for the average household. Over the past two years the tax increase is averaged at 1.26%-2015 the municipal taxes were flat.

This is a tremendous accomplishment for the Mayor and Council-The budget is lean and municipal services have not decreased.

PAH thanked all involved with the process. Mr. Trivedi has proven himself over and over, by working well with Council to provide a working budget for all departments at minimal cost to our residents.

(JC) Recreation Commission, Liaison to Board of Education, Public Information Ordinance will be introduced tonight to increase filed fees and enforce tennis badges.

Commission coaches will all be required to take the Rutgers Safety Concussion training which will be hosted in Harrington Park.

(PAH) Mayor Hoelscher

Councilwoman Chung appointed to DPW Committee to replace Michael Rutigliano who resigned from Council.

Megan Dippolito appointed to Recreation Commission to fill Unexpired Term of Siobhan Bailey-Ms. Bailey is now the Borough Prosecutor so she cannot hold that position. Ms. Dippolito will fill the unexpired term through 2017. Ms. Dippolito brings quite a bit of understanding of organized sports groups and the overall benefits of good health since she currently runs a Couch to 5K program that is open to all ages.

Request for Motion to Appoint-Robert Budinich appointed to Board of Adjustment Alternate B

There was a misunderstanding regarding the original appointment to the Board of Adjustment. Mr. Lander chose not to assume the position and was not sworn in. Motion to approve Mr. Robert Budinich as Alternate B to the Board of Adjustment was made by Councilman Napolitano, with a second by Councilman Pedersen. Addendum A Resolution 2016-40

AUTHORIZE SHARED SERVICES AGREEMENT FOR SHORT TERM EMERGENCY SHARING OF FIRE APPARATUS BETWEEN THE COUNTY OF BERGEN AND THE BOROUGH OF HARRINGTON PARK.

WHEREAS, the County of Bergen operates the Bergen County Law and Public Safety Institute (the "Institute"); and

WHEREAS, the County of Bergen owns certain fire apparatus, including ladder vehicles and engines (Fire Apparatus) used for training firefighters; and

WHEREAS, in furtherance of the County Executive's shared services initiative, the County seeks to establish a program to make certain Fire Apparatus available to the municipalities within Bergen County on a temporary/ emergency basis for use as front line fire apparatus when not needed for training purposes (Fire Apparatus Loaner Program); and

WHEREAS, the County has determined that by entering into a Shared Service Agreement governing the terms for borrowing the County's Fire Apparatus in advance of a municipality's need to utilize the Fire Apparatus, the parties will be able to facilitate the prompt availability of the Fire Apparatus at such time as a municipality has a need to utilize it;

WHEREAS, the governing body of the Borough of Harrington Park has determined that it is in the best interest of the residents and taxpayers of the municipality to enter into the SHARED SERVICES AGREEMENT FOR SHORT TERM EMERGENCY SHARING OF FIRE APPARATUS BETWEEN THE COUNTY OF BERGEN AND THE BOROUGH OF HARRINGTON PARK, subject to the terms and conditions set forth in the Agreement,

NOW, THEREFORE, BE IT RESOLVED by the governing body of the Borough of Harrington Park as follows:

- 1. The recitals set forth above are incorporated into the body of this resolution as if set forth at length herein.
- 2. The Borough of Harrington Park hereby accepts the terms of the Agreement from the County of Bergen as set forth above, subject to the terms of the Agreement annexed hereto as Exhibit A.
- 3. The Borough of Harrington Park is hereby authorized to execute an Agreement with the County of Bergen in the form annexed hereto as Exhibit A, together with any other documents necessary to implement the Fire Apparatus Loaner Program as set forth in the Agreement and all other documents to be in forms approved by the County of Bergen Counsel.

Addendum B Resolution 2016-41 APPOINTMENT OF BOROUGH MUNICIPAL JUDGE TO FILL UNEXPIRED TERM

Now therefore, be it Resolved by the Mayor and Council of the Borough of Harrington Park agree that the Senate and Assembly should take no further action on Senate Bills S781 and S782 to amend the Open Public Records Act and the Open Public Meetings Act

Addendum H ORDINANCE CONCERNING FALSE FIRE ALARMS BOROUGH OF HARRINGTON PARK Proposed ORDINANCE # 701

WHEREAS, the Harrington Park Fire Department is charged with responsibility to protect the lives and property of the citizenry of the Borough of Harrington Park,

WHEREAS, the ability to provide life and property firefighting services is greatly hampered by the response of the Harrington Park Fire Department to alarms that are unnecessary and false,

WHEREAS, it has been reported that the Harrington Park Fire Department is experiencing an inordinate amount of "false fire alarm" notifications,

WHEREAS, The Mayor & Council have determined that procedures must be adopted to address these "false fire alarms" by requiring owners of property to assure that their alarm systems are constantly monitored and repaired,

WHEREAS, this Ordinance shall in no way modify those "false alarms" deliberately made by any individual or entity and as otherwise specifically addressed by any other New Jersey statute, rule or regulation, which carries its own predicate fines and penalties,

NOW THEREFORE BE IT ORDAINED that the Borough of Harrington Park hereby adopts, ratifies and confirms the language written below and referred to as "Ordinance concerning False Fire Alarms"

Excessive False Fire Alarm Fines

- A. A false fire alarm shall be any transmission, either directly or indirectly, to the Harrington Park Fire Department of any automatic fire alarm, smoke alarm, carbon monoxide alarm, fire sprinkler water flow alarm, which was not caused by an actual fire, smoke condition, or other condition requiring the response of the Harrington Park Fire Department.
- B. The Harrington Park Fire Department shall investigate and determine the cause of any false alarm, as it is defined in this section, and shall maintain a list of all false alarms. Said list shall identify the location of each false alarm, the number of false alarms at the location, and the reason for the false alarm.
- C. Upon the determination that a false alarm has occurred, the Fire Chief or his designated representative shall promptly notify the Fire Marshal, who shall issue a violation notice to the alarm user or proprietor advising that all subsequent false alarms shall be a violation of this code subject to an excessive false alarm fine.
- D. An alarm user, at a single site, will receive one free false alarm per year. If the alarm user changes (e.g., sale of business) the new alarm user will receive one free false alarm during the current year.
- E. If it becomes necessary to assess an excessive false alarm fine, the Fire Marshal shall serve upon the user in person or send a penalty notice to the alarm user by mail. The notice shall include:
 - (1) The date, time, and location of the false alarm.
 - (2) The amount of the fine.
- F. Payment of the false alarm fee must be received within 14 calendar days from the date of delivery as listed on the certified mail receipt.
- G. All provisions of the New Jersey Uniform Fire Code with respect to the maintenance of fire alarms shall continue to apply.

Violations and Penalties

A. The following penalties shall apply to false alarms at commercial properties:

These penalties shall reset and start anew on January 1st of each year.

B. All penalties assessed for violations of this article shall be paid into the Harrington Park Fire Department penalty account.

Any provision of this ordinance found to be in conflict with any other law, rule or regulation shall be stricken and all other provisions herein shall survive and remain in full force and effect.

BOROUGH OF HARRINGTON PARK Proposed ORDINANCE #702 RECREATION FEES

AN ORDINANCE TO AMEND & ESTABLISH FEES TO BE CHARGED BY THE RECREATION COMMISSION FOR USE OF RECREATIONAL FACILITIES

Whereas, the Mayor and Council of the Borough of Harrington Park have determined that it is in the best interest of the Borough to amend or create certain fees and to provide for payment of others as may be recommended by the Recreation Commission; and

Whereas, the amendment/establishment of such fees shall provide for better, improved and continued Borough services as specifically considered and approved by the Recreation Commission;

NOW THEREFORE BE IT ORDAINED by the Mayor and Council of the Borough of Harrington Park as follows:

- 1) Section 373-4 shall be established and provide for fees to be paid for the use of Borough of Harrington Park recreational facilities as follows:
 - a) Tennis Badges shall be sold at the rate of \$25 per individual or family for residents of the Borough of Harrington Park.
 - b) Field Usage Fee shall be \$75 per game/practice per field.
